


ssociates in the Early Childhood Education Program are all about learning and review as they take part in a project funded by the Mission and Ministry Grant—Family Care, Teacher Education and Counseling Resources. Mission and Ministry, Inc. the granting entity of the Daughters of Charity Province of St. Louise, has awarded Daughters of Charity Services of San Antonio a grant of \$100,000 for teacher training and other support activities in the early childhood education program.

Training sessions took place Wednesdays and Fridays on the DePaul Campus during the month



Message from the President/CEO

o man is an island, entire of itself" are famous words written by English poet John Donne in 1624. Today we would say, "No *person* is an island," but I would like to apply this line of poetry to Daughters of Charity Services of San Antonio and say, "No *organization* is an island."

The work we do in south San Antonio and Bexar County in some of our poorest neighborhoods is supported by a solid base of partnerships with other local organizations.

Foremost among them is Methodist Healthcare Ministries (MHM), a private, faithbased, not-for-profit organization dedicated to

providing medical, dental and health-related human services to low-income families and the uninsured in South Texas. MHM is a major funder of our medical and dental programs. Other substantial funding for medical programs comes from the Baptist Health Foundation of San Antonio, which distributes grants annually to not-for-profit organizations that provide healthcare services and health education throughout Bexar County and South Texas.

The Charity Ball Association, a women's group whose mission is to support and enhance the quality of life for children of Bexar County, has been generous in funding equipment and capital needs, and the United Way of San Antonio and Bexar County is also a significant supporter of program needs.

Support isn't only financial. We turn to Community Medicine Associates, the primary care and multi-specialty group of University Health System (UHS), for medical providers who work at La Misión Family Health Care. UHS also handles our electronic medical records system and patient billing. The University of Texas Health Science Center, School of Health Professions furnishes interns who help with staffing needs in primary care. The Family Service Association makes available an early childhood mental health clinician at one of the child care centers weekly. The American Heart Association and the American Cancer Society give classes for our clients.

Brighton Center, which works with special needs children and their families, sends us referrals and assists with teacher training. CentroMed refers clients to us and conducts parenting classes for our parents. CommuniCare and Catholic Charities both refer clients. The Food Bank parks its semi-trailer in our parking lot once a month to distribute groceries to individuals and families. The St. Vincent DePaul Society conducts a program at El Carmen that frees up our social services staff to deal with other substantive issues. The local school districts in our area, Harlandale, San Antonio, South San Antonio, and Southside, all refer clients to us.

There are more examples I could cite, but I'm running out of space. You get the idea. Daughters of Charity Services is not an island, nor are our partners in this mutually supportive, beneficial, and interactive network of person-centered care. We thank them all.
